Legal Updates

Shanghai Tax Administration Issues Notice on Further Improving the Inspection Service of Individual Income Tax Payment Voucher for Equity Change Registration

On November 28, Shanghai Municipal Tax Service, State Taxation Administration issued Notice on Further Improving the Inspection Service of Individual Income Tax Payment Voucher for Equity Change Registration (the "Notice"), which was officially implemented from December 20.

The Notice clarifies that if an individual applies for the change registration of shareholder for equity transfers, before registering the change with the administration for market regulation, the withholding agent and taxpayer shall file tax returns with the competent tax authorities at the place where the invested enterprise is located according to law. The Shanghai Municipal Tax Service, State Taxation Administration and the Shanghai Municipal Administration for Market Regulation implement an automatic interactive mechanism of personal equity transfer information, and the administration for market regulation can handle the registration of equity change according to the Tax Payment Form of Equity Change of Natural Person Shareholders provided by the tax authorities.

NISSTC Issues the Industrial Internet Enterprise Cyber Security Part 4: Protection Requirements of Data (Draft for Comment)

On December 1, the National Information Security Standardization Technical Committee ("NISSTC") issued the Industrial Internet Enterprise Cyber Security Part 4: Protection Requirements of Data (Draft for Comment) (the "Requirements"), which seeks comments by January 30, 2023.

The Requirements stipulates the security protection process, protection requirements and security management requirements of different levels of industrial Internet data, which are applicable to industrial enterprises, industrial Internet platform enterprises and industrial Internet identity analysis enterprises that apply industrial Internet to carry out data protection, and define the data security protection process, data classification, the classification protection requirements of the whole life cycle and data security management requirements of industrial Internet.

SAMR Issues Law Enforcement Guide on Use of Absolute Wording in Advertising (Draft for Comment)

On December 7, the State Administration for Market Regulation issued Law Enforcement Guide on Use of Absolute Wording in Advertising (Draft for Comment) (the "Guide"), which seeks comments by January 6, 2023.

The Guide clarifies that the provisions of the Advertising Law on the use of absolute wording would not be applicable if the use of an absolute term in an advertising does not target the promoted goods, or does not have the objective results of misleading the consumers or defaming other operators. Use of absolute wording in an advertisement for the first time with minor harmful consequences and the act is corrected promptly may not be given a penalty. Use of absolute wording in one's own business premises or release of an advertising on one's own media that lasts a shorter time or has few viewers and does not cause harmful consequences or causes minor harmful consequences may be given a lighter penalty. The Guide also points out that use of absolute wording related to efficacy, cure rates and efficiency in advertising of medical services, medicines, medical devices, health foods and formula foods for special medical purposes, as well as use of absolute wording related to investment yields and investment security in advertising of financial products, would not be generally considered as minor violations or having minor social harmfulness.

On December 7, Shanghai Municipal People's Government issued the Several Measures on Further Reducing Institutional Transaction Costs to Further Unleash the Vitality of Market Entities (the "Measures"), which came into effect from the date of promulgation.

The Measures proposes to improve the convenience of cross-border trade, strengthen the RCEP enterprise service consultation station, guide enterprises to improve the utilization rate of the agreed preferential, and expand the scale of import and export trade with member countries. For express and perishable goods originating from RCEP member countries that arrive at the workplace under customs supervision and complete submission of relevant information, the convenience measures for release within 6 hours shall be implemented. Optimize the service function of "Single Window" in Shanghai's international trade. By the end of 2022, the rules of origin inquiry system will be put into use and the optimal tariff rate inquiry system will be updated to facilitate enterprises to inquire and enjoy the relevant benefits. Further optimize the supervision process on the return of the goods under the direct purchase import mode of the cross-border e-commerce, and allow export commodities and returned re-export commodities to be packaged in one package and transported overseas. Shipping companies and port management enterprises are encouraged to use block-chain technology to carry out paperless exchange of B/L, and get through the paperless "last mile" of the whole logistics process at the ports.

MIIT Issues the Administrative Provisions on Deep Synthesis of Internet Information Service

On December 12, the Ministry of Industry and Information Technology ("MIIT") issued the Administrative Provisions on Deep Synthesis of Internet Information Service (the "Regulations"), which will come into effect on January 10, 2023.

The Regulations clarifies the management norms of deep synthesis data and technology, requiring deep synthesis service providers and technical supporters to ensure data security, pay attention to protecting personal information, and conduct safety assessment on tools that produce or edit biometric information and information that may involve national security, national image, national interests, etc., and require that services such as intelligent dialogue, synthesized human voice, human face generation, etc. shall be clearly marked to avoid confusion or misidentification.

Management in the Industrial and Information Sector (for Trial Implementation) (the "Measures"), which will come into effect on January 1, 2023.

The Measures is applicable to the data processing activities and safety supervision in the industrial and information fields carried out in China. Data in the field of industrial and information include industrial data, telecommunications data and radio data. Data processors in the field of industrial and information should regularly sort out data, identify important data and core data in accordance with relevant standards and specifications and form a specific catalog. To provide data externally, the scope, categories, conditions, procedures, etc. should be clearly provided. For the external transfer of important data and core data, data processors shall sign a data security agreement with the data recipient.

NISSTC Issues Specification V2.0 on Safety Authentication for Cross-border Personal Information Processing Activities

On December 16, the National Information Security Standardization Technical Committee ("NISSTC") issued the Guide to Cybersecurity Standards - Specification on Security Authentication for Cross-border Personal Information Processing Activities V2.0 (the "Specification"). The Specification, including basic principles, the personal information protection by personal information processors and overseas in cross-border personal information processing activities, and the protection of the rights and interests of personal information subjects, provides basis for authentication institutions to carry out authentication for the cross-border personal information processing activities conducted by personal information processors, and also offers reference for personal information processors to regulate their cross-border personal information processing activities. The specification requires that both personal information processors and overseas recipients, who carry out cross-border personal information processing activities, shall appoint a person in charge of personal information protection, set up a personal information protection agency, as well as agree and jointly abide by the same cross-border personal information processing rules.

MEM Issues Notice on Strengthening the Safety Management for Online Sales of Hazardous Chemicals

On December 21, Ministry of Emergency Management ("MEM") issued the Notice on Strengthening the Safety Management for Online Sales of Hazardous Chemicals (the "Notice"), which were implemented from the date of publication.

The Notice clarifies that the e-commerce platform should not provide operators on them with the services for release of sales information related to hazardous chemicals, was expanded through establishment the offices in Beijing, Dalian, Wuhan, and Tokyo. individuals are prohibited from releasing sales information of hazardous chemicals online, and network service providers are not allowed to provide individuals or organizations that have not obtained the work safety license for hazardous chemicals producers or the license for operation of hazardous chemicals with the network access services for release of information on hazardous chemicals, instead, they should strengthen the management of their access websites and users' release of information, and conduct periodical inspection on released information.
