# <u>State Council's Latest Negative List for Pilot FTZs Only</u> <u>Includes Less than 100 Entries</u>

The General Office of the State Council has issued the Special Administrative Measures (Negative List) for Foreign Investment Access to Pilot Free Trade Zones (FTZs) (2017 Edition), effective from July 10, 2017. Compared to its previous edition, the latest negative list covering existing 11 FTZs cancels 10 entries and 27 measures.
