• <u>State Council Vows to Further Open up Core Fields in</u> Beijing's Service Sector

Recently, the State Council approved in principle the Comprehensive Pilot Program on Deepening Reform and Further Opening up Beijing's Service Sector (the "Program"), according to its official reply to the Program.

The status of personal information protection in China

On November 7, 2016, China published the Cybersecurity Law of the People's Republic of China which became effective on 1 June, 2017. Although most foreign media reports focus on the terms relating to the mandatory requirements imposed on Cybersecurity systems of internet enterprises such as the national security examinations, we think foreigners living in China need also to know the terms of the law relating to personal information protection.

A foreigner living in China may be met with the situation in which a person of strength who knows your name, home address, and even what you have purchased from an e-commerce website, calls you on your personal phone number. This would mean that your personal information had been leaked by the person to whom you had disclose such information in making applications during the browsing of websites, purchasing products and/or services, or handle other matters. Because of the absence of laws which regulate the obtaining, holding, use and, disclosure of such personal information, the illegal obtaining and disclosing of personal information has become a common problem in China and countless individuals have been defrauded by criminals through the use of said personal information.
