2.1 The National Policies

2.1.1 The Guidelines on Tax Preference of preventing and controlling COVID-19

“The Guidelines” are collected by the State Administration of Taxation on February 11th, 2020 based on the relevant policies of tax preference on the key areas and industries for preventing and controlling the COVID-19. The Guidelines include the applicable targets, content and basis, involving supporting the protective treatment, materials supply, encouraging the charitable donation, supporting returning to work and other 12 policies.

2.1.2 The Guidelines of Air conditioning and ventilation system operation in office and public places during COVID-19

On February 12th, 2020, the government issued this Guidelines to prevent the spread of COVID-19 because of the operation of air conditioning and ventilation system. The guidelines regulate the reasonable and safe usage of the air conditioning and ventilation system operation in office and public places.

2.2 The Provincial Policies

2.2.1 Beijing: Measures for supporting the enterprises with liability insurance of safe production

The measures were issued on February 12th, 2020, aiming at reducing the COVID-19's impact on the enterprises with liability insurance of safe production, especially the middle, small and micro enterprises, to help the enterprises overcome the difficulties and develop stably. The measures involve extending the insurance period without adding the insurance premium, the priority usage of preventive cost on the preventing work and publicity cost on procurement of preventing materials and others.

2.2.2 Jiading and Kunshan/Jinshan, Pinhu and Jiashan: Policies of Mutual recognition of the permit of passage and vehicles

The government of Jiading and Kunshan made the Memo that the “Working Permit” and “Temporary Passing Permit” issued by Jiading and Kunshan separately would be recognized by both places. Any enterprises with the employees needing to cross province can apply for the government. If the employees' information is in accordance with the Permit's information, they could enter and leave this two place through the special channel, without submitting the personal information again.

Moreover, in order to give the employees convenience in commuting to and from Jinshan, Pinhu and Jiashan, the government issued the mutual recognition of the permit of passage and vehicles to solve the problem of cross-provincial vehicle restrictions and personnel return to isolation.



2.2.3 Wuxi: The guidelines on implementation of construction contract and adjustment of project price during the period of COVID-19

This Guidelines was issued on February 8th, 2020, putting forward that the force majeure factors and the losses and expenses incurred by COVID-19, should be performed according to the regulations of contract. If there is no contract, performing according to the *Specification of Quantity Billing in Construction Projects*' principle of force majeure provisions, shall be borne by both contractor respectively. At the same time, during the national legal spring break, the unit wage of labor settlement for the construction project of epidemic prevention and control points shall be calculated based on three times of the manual and guided price. If the contract is agreed, it shall be paid according to the contract and shall not be lower than the above standard.

2.2.4 Nanjing: The implementing measures on exempting the middle, small and micro enterprises' dishonest behavior incurred by COVID-19

The implementing measures are issued on February 14th, 2020. The main purpose is to optimize government services and promote the stable development of middle, small and micro enterprises. The implementation's field mainly involves the impact of the epidemic, and the force majeure caused by various kinds of breach of contract. This type of breach is exempted from inclusion in the breach record and no credit penalty is imposed.
