1.1 The State Council	3/3/2020 Notice: Simplify the approval process and promote the enterprises' resumption of work and production steadily	The State Council issued policies involving five fields to cancel the unreasonable approval process, and provide convenient service for promoting the enterprises' resumption of work and production steadily.

Area	Time	Overview of Policy
2.1 Beijing	3/3/2020 Notice: Phased reduction of employees' basic medical insurance	For all enterprises participating in the insurance, half reduction of enterprises' basic medical insurance for employees will be applied from February to June in 2020.
2.2 Beijing	3/8/2020 Notice: Phased reduction of endowment insurance, unemployment insurance and industrial injury insurance ("three social insurance") and the application for holdover of insurance	a. For micro, small and medium-sized enterprises participating in the insurance, exemption of enterprises' three social insurance will be applied from February to June in 2020. b. For large enterprises participating in the insurance, half reduction of enterprises' three social insurance will be applied from February to April in 2020. c. The instructions of application for holdover of insurance.

7.1 Chengdu City	3/4/2020 Measures for promoting the development of cultural tourism during COVID-19	Twenty measures include ensuring the safe resumption of work and production, reducing the costs of enterprises' operation, strengthening financial assistance, increasing financial support and others.

Area	Time	Overview of Policy
8.1 Shandong Province	3/5/2020 Notice: Strengthen the management of the health card	<i>Shandong Health Card</i> is valid for 14 days and is commonly used in Shandong. People holding the card within the valid period will not be quarantined after being checked. During this period, regional governments are forbidden to establish requirements for health certificates, and the practical requirements shall be abolished.



8.2 Qingdao City	3/7/2020 Subsidies for enterprises' policy of working instead of training	Explaining the standard and application process for enterprises' carrying out the policy of working instead of training.
