1. **Policies in Beijing**

Area	Time	Overview of Policy
1.1 Beijing	3/11/2020 Notice: Measures for keeping the labor relationship of employees who are staying in Hubei and not returning to Beijing	This Notice determines the policies for employees who are staying in Hubei and not returning to Beijing, including the prevention and control of the enterprise, the duty of investigation, the management of labor relationship, the payment of wages, the subsidies for temporary jobs and others.
1.2 Beijing	3/14/2020 The Third Guideline for the operation of catering service enterprises during COVID-19	This Guideline applies to catering enterprises and their stores, enterprises' canteen, the third-party platform of network catering service and other catering enterprises. The Guideline illustrates the requirements for catering enterprises, for example, the serving spoons and chopsticks, one meter's space and others.

2.1 Shangh	3/15/2020 Periodical reduction of enterprises' cost on electricity and gas	 From February 1st 2020 to June 30th 2020, reducing the price of electricity by 5%; From February 22nd 2020 to March 31st 2020, reducing the price of general non-residential gas by 10%; From April 1st 2020 to June 30th 2020, reducing the price of general non-residential gas by 5%.

3.1 Jiangsu Province	3/15/2020 The Guidelines for Jiangsu's policies of favoring enterprises	Enterprises can apply and search through Jiangsu government service network or the local government service network.
3.2 Suzhou City	3/13/2020 Half reduction of the employees' medical insurance for five months	From February to June in 2020, half reduction of the employees' medical insurance shall be applied, including the basic medical insurance, and local supplementary medical insurance, except for the maternity insurance.

The action plan is around one hundred and fifteen billion RMB.

5.1 Shenzhen City	3/12/2020 Periodical policy for reduction, defer and exemption of enterprises' medical insurance	 Half reduction of the enterprises' basic medical insurance periodically; Exemption of the enterprises' local supplementary medical insurance periodically; One level reduction of the enterprises' basic medical insurance periodically; Deferred policy of payment during COVID-19.

6.1 Sichuan Province	3/14/2020 Notice: Acceptance of the health code of 10 provinces	The health code of Guangdong, Zhejiang, Chongqing, Yunnan, Jiangsu, Hainan, Guizhou, Fujian, Shanghai and Shandong shall be accepted in Sichuan and no other restrictions or quarantines measures shall be set (except for person with abnormal body temperature and respiratory symptoms).
6.1 Chengdu City	3/13/2020 Measures for the prevention and control of COVID-19 and stabilizing the resumption of work for service industry	Measures include thirty articles involved six fields, including speeding up the resumption of work for service industry, implementing the policies for prevention and control of COVID-19 and others.

7.1 Shandong Province	3/12/2020 Notice: Strengthen the report system of people entering Shandong	 People entering Shandong shall report to the company or the community; Hotels shall perform obligations of reporting people entering Shandong; Companies, communities and leasers shall report information of people entering Shandong; Companies and communities shall tell people entering Shandong to apply the health code immediately. 	
7.2 Qingdao City	3/11/2020 Notice: Human resources services organizations and dispatch institutions can apply for the returning of the unemployment insurance	This Notice includes the human resources services organizations and dispatch institutions into the policy of application for the returning of the unemployment insurance.	





8. Policies in Liaoning

Area	Time	Overview of Policy
8.1 Dalian City	3/13/2020 Notice: periodical reduction of social insurance	Periodical reduction of enterprises' basic endowment insurance, unemployment insurance and industrial injury insurance ("three social insurance") and the enterprises' part of basic medical insurance.

9. Policies in Hubei

Area	Time	Overview of Policy
9.1 Hubei	3/13/2020 Notice: Periodical reduction of employees' basic medical insurance	This Notices illustrated that the half reduction of the enterprises' part of employees' medical insurance should be applied and every city government shall make the tailor-made policy.
9.2 Hubei	3/12/2020 Notice: Measures for promoting the development of economic in Hubei	This Notice includes thirty measures, involving eight fields, strengthening the support for finance, reducing the cost for market units, optimizing the business environment.
