

## Shanghai adds eight countries into quarantine list

Shanghai Municipal Government announced on March 19, 2020, from March 20, 2020, in addition to the coronavirus affected countries previously announced (South Korea, Italy, Iran, Japan, France, Spain, Germany, the United States, Britain, Switzerland, Sweden, Belgium, Norway, the Netherlands, Denmark, and Austria), people who have lived or travelled in other coronavirus affected countries, including Australia, Malaysia, Greece, Czech Republic, Finland, Qatar, Canada, and Saudi Arabia within the 14 days before their arrival in Shanghai, must undergo a 14-day quarantine at home or in designated places.

## Beijing's Latest Measures for Inbound Passengers

Authorities in Beijing has tightened up quarantine measures for inbound passengers to contain the rising risks of imported COVID-19 cases from March 19, 2020:

- (1) All passengers from overseas have to be put under quarantine in designated places for 14 days when they arrive in Beijing. Accommodation and dining fees at designated places need to be paid by passengers themselves. Passengers who are over 70 years old or under 14 years old, as well as pregnant women and with diseases who are not suited to be quarantined with others, can apply for a 14-day home quarantine after strict assessment. Inbound passengers with independent residential apartments in Beijing also have to be quarantined at designated places for 14 days.
- (2) Passengers shall apply to the community of residence for a 14-day home quarantine before entering Beijing. Passengers who do not apply for home-based quarantine before entering Beijing or their applications are not approved after the assessment shall be transferred to the designated places for quarantine. If the applications are approved after assessment, the time at the designated places waiting for the result of assessment shall be calculated into the period of 14-day home quarantine.
- (3) Passengers who arrived in Beijing through other Chinese city ports also must report their detailed health information and travel history to the community of residence in Beijing. And passengers have to undergo the quarantine measures mentioned above. Passengers found to have concealed their travel history will face legal punishment.

Some inbound flights to Beijing Capital International Airport will be taken a preposition quarantine in several airports around Beijing



Five central government departments (the Civil Aviation Administration, the General Administration of Customs, the Ministry of Foreign Affairs, the National Health Commission and the National Immigration Administration) issued a notice on March 19, 2020, that four international flights scheduled to land in Beijing within the next three days will be taken a preposition quarantine in several airports around Beijing.

Flight CA910 on March 20 from Moscow and flight CA934 on March 22 from Paris will be taken a preposition quarantine in Tianjin airport. Flight CA926 between March 20 and 22 from Tokyo will be taken a preposition quarantine in Hohhot (the capital city of Inner Mongolia autonomous region) airport. Flight HU7976 on March 21 and 22 from Toronto will be taken a preposition quarantine in Taiyuan (the capital city of Shanxi province) airport.

Passengers on the above flights will be subject to the health and quarantine process at these airports, and they will go through the entry procedures there. However, the checked baggage still needs to be cleared in Beijing. Passengers who don't exhibit any symptoms will be allowed to take the same plane to Beijing later.

According to the decision of Jiangsu Provincial Government, from March 20, 2020, in addition to the coronavirus affected countries previously announced (South Korea, Italy, Iran, Japan, France, Spain, Germany, the United States, Britain, Switzerland, Sweden, Belgium, Norway, the Netherlands, Denmark, and Austria), people who have lived or travelled in other coronavirus affected countries, including Australia, Malaysia, Greece, Czech Republic, Finland, Qatar, Canada, and Saudi Arabia within the 14 days before their arrival in Jiangsu, must undergo a 14-day quarantine in designated places (Passengers who are not suited to be quarantined at designated places can apply for a 14-day home quarantine).
