1. The National Policies

Department	Time	Overview of Policy
1.1 Ministry of Industry and Information Technology	3/23/2020 Notice: Promoting the industry chain's resumption of work synergistically	The Notice required the industrial chain's cooperation and joint resumption of work. The epidemic prevention shall be based on the classification and the whole industrial chain's resumption of work shall be promoted.
1.2 China Banking and Insurance Regulatory Commission	3/27/2020 Notice: Strengthening industry chain's resumption of work synergistically	The Notices proposed several measures to guide banks and insurance institutions to enhance financial support and services, unblock the capital flow of the industrial chain, and improve the overall effect of the industrial chain's cooperation on the resumption of work.
1.3 Ministry of Industry and Information Technology	3/25/2020 The Topic of supporting the resumption of work in finance and tax for COVID-19 was published	The Topic involved fiscal and tax policies, financial policies, other policies, and local policies, classifying the policies issued by the central and local governments.

2.1 Beijing	3/27/2020 Notice: Periodic adjustment of the sale price of natural gas for non-residents	From February 22 to June 30, the sale price of natural gas for non-residents shall be under periodic adjustment.
2.2 Beijing	3/17/2020 Notice: Issues related to the return of unemployment insurance	The standard of the return of unemployment insurance for micro, small and medium-sized enterprises will be raised to 100%.

3.1 Shanghai	3/25/2020 The Fifth Guidelines for enterprises' resumption of work	The Fifth Guideline enlarged the scope of resumption of work without record, which included book performance activities, chess, and card room, indoor swimming pool operations.

4.1 Jiangsu	3/23/2020 The Measures for promoting the stable development of the cultural tourism industry	The Measures included eighteen methods to promote the stable and high-quality development of the cultural tourism industry.
4.2 Jiangsu	3/24/2020 Notice: Providing the professional legal service to restore the normal life	The Notice proposed fifteen measures to restore the normal life and provide legal service, which focused on the performance of the contract, the debt, and the labor-capital relationship.

5.1 Zhejiang	3/24/2020 The Opinion for promoting the consumption and stabilizing the development of economic	The Opinion emphasized sixteen key tasks, including the digital life consumption and prosperity business circle to promote the stabilizing role of consumption in economic development and minimize the impact of COVID 19 on economic development.

6.1 Sichuan	3/25/2020 Notice: About the overall restoration of normal life	The Notice made several regulations on preventing the import of epidemic cases and restoring normal production and life.

7.1 Shandong Province	3/28/2020 Notice: Arrangement for epidemic prevention measures and promoting the restoration of life and production	The Notice proposed nineteen measures from six aspects to prevent the import of epidemic cases and promote the restoration of life and production quickly.
7.2 Shandong Province	3/27/2020 Temporary provisions for applying the health code in the resumption of work	The provisions regulated the application of the health code.
7.3 Qingdao City	3/21/2020 Measures for optimizing the approval service to support the enterprises' resumption of work and assist the development of	The Measures involved eighteen methods in six fields.

8.1 Liaoning	3/25/2020 Supplementary Notice: the arrangement for online job skills training during COVID-19	The Notices required that the training subsidy will be extended to “all kinds of small, medium and micro enterprises” and “employees who establish labor relations with enterprises and work (including labor dispatching personnel)”.

Area	Time	Overview of Policy
9.1 Guangdong	3/23/2020 Notice: Arrangement for epidemic prevention measures and promoting the restoration of life and production	The Notice proposed twenty-six methods to support the small and medium-sized enterprises' response to COVID-19 through promoting the production, reducing debt, supporting the finance and strengthening the service.

10. Policies in Hubei

Area	Time	Overview of Policy
10.1 Hubei	3/27/2020 Notice: Measures for keeping employment stable	The Notices proposed twenty-five measures to keep employment stable, which included ensuring the safe and orderly return to work, supporting enterprises in reducing the negative and stable levels of employment, and promoting multi-channel employment.
