1.1 Ministry ofTransport,GeneralAdministrationof Customs,Ministry ofCommerce,NationalRailwayAdministration,Civil Aviationof China, StatePost Bureau,and China StateRailway GroupCo., Ltd.	4/20/2020 Notice: Improvement of service for stabilizing foreign trade	The Notice requires to clear the foreign trade transport channel, implement the policy of periodically exempting import and export port construction fees, reducing fees for port service and port facilities and security. It also requires to study the policies of further reducing port fees, reducing government-set fees for port operations and services, and reducing logistics costs for import and export.
1.2 The State Council	4/21/2020 The executive meeting of the State Council	The meeting proposed that small and micro-businesses in the field of service and self-employed businesses that lease state-owned housing can be waived monthly rents for the first three months of the year. The lessor can be reduced or reduce the rent by the provisions of the current year property tax, urban land use tax.
